

Roy briefly reviewed how the assessment process will work as of January 1, 2018, if the remit passes. He noted that it will be very important for congregations to submit their assessments in a timely manner to ensure an accurate flow of funds back to the region from the denominational council. As well, it is important to ensure that updated statistical reports are forwarded when they are due so that assessments are being calculated based on the most updated numbers.

Roy thanked the congregations for the many warm welcomes he has received during his visits over the years.

From the Desk of Ian March-MacCuish

Prayer: O Majesty and Mercy, open us to wonder that we may be surprised by the greatness that awaits us in the smallest bud, the earliest sunrise, or the unexpected invitation from a neighbour. Let us always be expected to find your love incarnating among us in new ways. Amen.

Faith is the refusal to underestimate God. The world can be a difficult place. It is understandable that we lean into our survival instincts and work from our strengths most of the time. But, during this season of epiphany, we have been and are being reminded that God is always present, breaking in to shelter us, feed us, and show us glory. Approaching life with the willingness to be surprised is a spiritual practice. We often think we know the results. When we believe we can predict the outcome, we start to underestimate ourselves, judge others and withdraw our faith from God. Sometimes, God asks us to be open to the possibilities, to take another look, and to try again. Like a boat full of fish or a calling to volunteer on the church board, bringing in a food item for Bridges to Hope, help out a new ministry or program. We do so knowing that multitudes await us.

So much of what we are taught in life is to define things and ourselves. When we meet someone new, we introduce ourselves, and we make our best impression. When we try something strange, we draw on what we already know, the strengths and capacities we've practiced to get us through. Doubting ourselves, doubting others, makes us want to define and protect what we do know and can do. But what if we approached strangers and new experiences from a posture of surprise? Woke up to a day that may be different, to a world full of strangers to befriend? Developing a taste for something new can be more pleasurable than going through life armed and ready to judge. Faith in God invites us to have faith in ourselves and faith in others, and to show this through a willingness to be surprised by the manifold images of God in people and creatures all around us.

Many times on Sunday morning people ask if there is anything special today for church. I know why the question is asked. He or she is wondering if there is a baptism or special choir music or the youth group or Sunday school or Men's Club or UCW are taking part or offering leadership for worship. My answer is always the same, every Sunday is special, every service is unique and offers opportunities for being surprised. Epiphanies are discoveries that illuminate, or moments that reveal. So it is with each worship and by extension the work of the church.

The amount of volunteer work offered by our church is staggering and almost always surprising. The dinners, the potlucks, the worship services, donations of goods and labour and monetary resources all of this work, and I'm only scratching the surface, adds up to an enormous body of volunteer work. Through my pastoral visits I hear first-hand how our congregation has reached out time and time again in prayer and in faith to offer a listening ear, a sounding board, a hug, a prayer, to show that God's love is seen in each of us by the surprising ways we offer ministry. First United has been blessed by you, the volunteers, and I know you have been a blessing to others.

Outreach and Social Action Report-February 2019

The Outreach and Social Action Committee has been busy again this year, keeping members of our congregation updated on the happenings of our community of faith through our newsletter, our website http://www.firstunitedchurchmp.ca/ -(special thanks to Beulah Bouzane- BCI-Esolutions/Bouzane Consulting Inc.), Facebook and our weekly Constant Contact emails. Information on all these platforms are updated regularly- make sure you stay tuned, check in and follow us so you know what's happening in your church.

Minute for Mission

Each Sunday during our worship service you hear a "Minutes for Mission" being read. These are stories from a ministry supported by our gifts for Mission and Service. The theme of the stories during this year was Loving Our Neighbours:

"...You shall love the Lord your God with all your heart, and with all your soul, and with all your mind, and with all your strength.' The second is this, 'You shall love your neighbor as yourself.' There is no other commandment greater than these." —Mark 12:30–31

In the 2018, Minute for Mission Guide, Cheryl Curtis, Manager, Mission & Service Giving stated that: "Our gifts for Mission & Service enable ministries that truly fulfill the great commandment. Whether it is an act of service or advocacy, Mission & Service ministries speak and act lovingly of the dignity of all humanity and creation. To see with a compassionate gaze and offer compassionate service and advocacy—that is at the heart of our Mission & Service. May these stories draw you closer to each other."

Bridges to Hope

The first Sunday of each month has been designated as Bridges to Hope Sunday at First United. Members of the congregation are asked to bring non-perishable items, as well there are special envelopes available to make a monetary donation. There is also-a cart in the vestibule of the church-where the non-perishable food donations can be placed. At Easter and at Thanksgiving, we have special "reverse offerings" (food drive) to support Bridges to Hope.

At Bridges to Hope-the programming offers help to anyone requiring food aid assistance. It's not a hand out — it's a hand up, helping Newfoundland families and individuals move forward in life. Bridges to Hope serves the Northeast Avalon region. The clients are your neighbours, co-workers, and friends. That's why at Bridges to Hope the focus is "neighbours feeding neighbours." Clients come to us from every sector of society — no one is turned away. Bridges to Hope has several programs that your donations help to support the programs it offers to its clients which include:

Food Pantry: Clients access food aid assistance once a month and can receive a full food hamper or an emergency hamper. The full food hamper includes fresh baked bread, homemade soups and stews prepared in our community kitchen, plus other essential food items required to feed a family or an individual for up to five days. The emergency hamper is prepared, so that is can last 24 to 36 hours.

Community Kitchen: The kitchen is used daily to make fresh homemade bread for clients, they also make soups, stews, and roasted chicken, depending on availability of ingredients. When Bridges to Hope receives funding or requests from organizations, the kitchen is used as a learning classroom that teaches people how to make cost effective meals. Cooking programs are unique to the needs of each client group, such as a slow cooker program for single parents.

Community Outreach: Bridges to Hope also supports the community through an education outreach program called "Bag To School". The program supplied 600 students in grades K-12, with quality curriculum-based school supplies, all packaged in a book bag and ready for school.

Volunteer Programs: Bridges to Hope is powered by volunteers from a diverse cross section of the Community and Corporate Business sector. Bridges To Hope is highly respected as an environment that employs innovative initiatives to mobilize volunteers and supports advocates

who will become future philanthropic and community minded leaders. Bridges is a first-choice placement for Youth Leadership organizations like Canada World Youth and the Duke of Edinburgh Award Program. Bridges To Hope is highly regarded within the academic community — as an organization where students pursuing careers in social work, medicine and community services — come to do volunteer work or work placement.

Smart Snack Program: This program is Bridges to Hopes newest. With over 200 of monthly clients being school aged children, this program provides children with healthy essential food items that they would otherwise not have access to. Each Smart Snack kit holds 4-5 days worth of nutritious snacks that include protein, dairy, fruit and a homemade snack such as a bran muffin or energy bite.

Special Events & Fundraising

Again, this year Spirt of Newfoundland helped us get into the Christmas spirit on December 1st featuring the musical talents of Peter Halley and Shelley Neville with a Christmas Concert in the sanctuary.

As in previous years, the Good Friday Breakfast and the Breakfast with Santa were wonderful events for our church community, a chance for church members to get together and share a meal. These events take a lot planning, hard work, time and energy which does not go unnoticed.

Senior's Christmas Dinner ~ Sunday, December 16, 2018

This year, 119 seniors attended a turkey dinner in Trinity Hall and there were six dinners delivered. As the saying goes many hands make light work and it takes many to put this event together each year. Thanks, to all who help to make this event special—the cooking crew, those who helped to prepare the meal, set up, served, peeled vegetables, cleaned up, bought groceries, delivered meals, poured the tea and coffee, washed dishes and provided musical entertainment. Many of our seniors stayed and attended the *Annual Youth Group Christmas Vesper Service* which the youth group had at 7 pm that evening.

Thanks so much to all the members of my committee, flow board members and those who have helped in anyway throughout the year.

Report to our Partner Churches for 2018

Vision

A community where each person has access to sufficient and wholesome food **Mission**

Inspired by values of dignity, respect and hospitality, Bridges to Hope supports people in need through direct food assistance, instructional cooking programs, and food security advocacy in metropolitan St. John's. Fundraising, food donation, volunteer participation, and a healthy workplace are essential elements in sustaining these activities. In association with the United and Presbyterian churches, Bridges to Hope is a non-profit society committed to accountable stewardship, good governance, open communication, and justice in all our relations.

Bridges To Hope is a unique partnership of Presbyterian and United Churches operating a food pantry and other programs. Please visit our website, http://www.bridgestohope.ca and Facebook page, https://www.facebook.com to become more familiar with our services.

Food Pantry

Our core activity is the operation of the food pantry from our location on Cookstown Road. This program is organized by staff and is performed by a dedicated team of volunteers. In summer months we also benefit from students who help us maintain a regular service through the vacation season. Demand for hampers continues to rise. In 2018 we served 10,336, an increase of 4.5% over 2017, and exceeding 10,000 for the first time. Food donations of staple food product come from several sources including: our church partners; corporate and school food drives; Community Food Sharing Association; purchases; baking on site. Volunteer bakers cook bread daily for hampers and we also purchase fresh vegetables and fruit as much as we can. The rate of supply of food product varies considerably throughout the year. We are grateful for food donations at any time and encourage donors to remember us in the 'lower' summer months. We are able to maintain our hamper standards throughout the year by careful management of available product, supplemented by purchases.

Christmas Hampers

Again this year we provided Christmas hampers and again Rotary was the prime organizer and sponsor. Their continuing interest and involvement in this project is very much appreciated. This year we registered 360 families. All these families received a complete hamper from turkey to fixin's and more besides. St. Andrew's church generously made the Kirk Hall available to us again this year for several days in mid-December as home base for the preparation and then delivery of these hampers. It is a significant team effort and the support of individual volunteers and of HMCS Cabot personnel contributed greatly to satisfactory completion of the project.

Bags To School

This year we provided 602 kits of school bags and supplies to registered children and youth in all grades. This is a new high and is 9% higher than 2017. We appreciate the generous support again this year of our sponsor, Exxon Mobil, and the involvement of VOCM Cares, Pipers, and other partners and donors. The project culminates in a massive assembly process and again this year we were very thankful to have the facilities at St. David's church to perform this work.

Marketing

During 2018 we conducted an aggressive initiative to raise our profile and community awareness through use of social media, primarily Facebook. Our manager also took advantage of many opportunities to be available to news media for interviews and reports. We have already seen the tangible results of this profile in the community through increased traffic on Facebook, especially when people volunteer to push the Donate button which we conveniently provide on our website, using Canada Helps.

Special Financial Campaigns

The increased public profile has contributed to an increase in public financial support. In the

spring we had a special "Generous Helping, backyard BBQ" fundraiser, continuing a program begun in 2017. This was a significant event, involving a lot of dedicated volunteer organizing effort which, while successful, suffered from an unfortunate cold weather event. During the summer we were profiled in a new project "Smart Snacks" for school kits which exceeded objectives and enabled us to fill a food gap in a positive way. We also engaged in a successful "Healthy Hamper" campaign. Late in the fall, in the important pre-Christmas period, we organized a "Miracle on Cookstown Road" fundraiser which achieved our objectives.



Thank You

There are many other programs and initiatives we could mention. All are important and contributed to overall success. In summary, we simply observe that there are many, many individuals and organizations that voluntarily choose to support us and what we do. We also acknowledge that in 2018 the financial support from our partner churches increased by 19.6% to \$22,200. We are humbled by your confidence and trust, and we seek to be worthy of your support as we work together to improve the lives of those who come to us for support.

Once again, we extend a sincere THANK YOU to you all for your continued support. We invite you to attend our annual meeting later this spring.

The General Protestant Cemetery Trustee Board Inc. Annual Report for 2018

We continue to make improvements to our cemeteries each year. In addition to our regular maintenance at our cemeteries, we filled, leveled and re-sodded a large number of graves and leveled a number of headstones in Mount Pleasant Cemetery and the General Protestant Cemetery.

During the past year we had 218 burials, a decrease of 8 from the previous year; and of these, 136 (62.4%) were cremations. In comparison, in 2001 there was a total of 240 burials and of these there were 60 (25%) cremations.

Your Board met nine (9) times during the past year.

Memorial Gardens:

This past summer we completed the installation of chain link fence along the east boundary. In addition, we installed similar fencing along the south boundary as far as the tree line in the SW corner of the cleared property.

We had planned to pave approximately half of the designated parking area, to an overall amount of \$150,000.00. However, the City of St John's has objected to the area designated and has not yet approved our application to do this work. Our consultant, MAE Design Ltd., is working to resolve the issues with the City. We expect the problems will be resolved before the construction season begins so we can award the contract. The Board is committed to have the parking area paved this year.

All maintenance at Memorial Gardens, such as grass cutting, snow clearing, etc, is carried out by our own employees.

We operate six days a week, sometimes through difficult and challenging situations, especially during the winter season.

Stewardship Report 2018

Our Stewardship Committee is pleased to report that on December 31, 2018 all bills were paid and all financial obligations were met, eg. - Mission and Service Fund, Food Bank, District Assessment, Cemetery Fund and VOWR.

I would like to bring to your attention that for 2018 our operating Account had a deficit of \$8,273.54 and our Building Fund Account had a deficit of \$6,731.96. We were able to meet our financial obligations because of the surplus from previous years.

Our Loan balance as of December 31, 2018 is \$301,000.00. For us to continue meeting this financial obligation we are asking each family of our congregation to contribute an extra \$10.00 per month to our Building Fund account; however, this is **not** to be at the expense of contributions to our general revenues.

Our Ways and Means Committee in cooperation with the Official Board is making plans for 2019 so that this deficit hopefully doesn't happen again this year.

We had previously mentioned to the congregation about setting up pre-authorized (PAR) for your monthly contributions. We are strongly recommending that you (the congregation) take a serious look at this option. It is very important to our cash flow position especially during the summer months. If you wish to make your contributions by post - dated cheques that would also be greatly appreciated. The pre-authorized forms are available at the church office.

On behalf of the Stewardship Committee, I want to thank all members of the congregation for your support during 2018. While we may have challenges ahead of us, I am quite confident that with your continued support, we will overcome to grow as a community of faith.

Qualified Opinion

We have audited the accompanying financial statements of First United Church, which comprise the statement of revenue, expenditures and changes in bank balance as at December 31, 2018, and a summary of significant accounting policies and other supplementary information.

In our opinion, except for the effects of the matter described in the basis for qualified opinion paragraph, the accompanying financial statements present fairly, in all material respects, the financial position of the First United Church as at December 31, 2018, and the results of its operations for the year then ended in accordance with accounting standards for not for profit organizations.

Basis for Qualified Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the parish in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements.

In common with many charitable organizations, the church derives receipts from parishioner cash donations, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of these cash receipts was limited to the amounts recorded in the records of the church and we were not able to determine whether any adjustments might be necessary to the cash contributions, excess (deficiency) of receipts over disbursements and cash on hand. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian Generally Accepted Accounting Standards for Not for Profit Organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing these financial statements, management is responsible for assessing the parish's ability to continue as a going concern, disclosing, as applicable, matters related to a going concern and using the going concern basis of accounting unless management either intends to liquidate the parish or to cease operations, or has no realistic alternative to do so.

Those charged with governance are responsible for overseeing the parish's financial reporting process.

December 31, 2018

Nature of Operations

The First United Church is a faith community within the City of Mount Pearl, Newfoundland, committed to meeting spiritual, emotional, physical, social and psychological needs of members of the congregation. The organization is committed to the maintenance and development of the church building and property to serve as a means by which to carry out the mission of the congregation.

The First United Church is a not for profit organization and as such is exempt from income tax under the income tax act.

1. Significant Accounting Policies

Revenue recognition

Income is recognized when donations and other sources of revenue are received.

Use of estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenditures during the reporting periods. Actual results could differ from those estimates. These estimates are reviewed periodically, and as adjustments become necessary, they are reported in earnings in the period in which they become known.

2. Fair Value of Financial Instruments

The carrying value of cash and cash equivalents, accounts receivable and accounts payable and accrued liabilities approximate fair market value due to the relatively short period to maturity of the investments.
